Closure of a degree program	The program was originally a joint offering between McMaster University, the University of Toronto, the University of Waterloo, and the University of Western Ontario for working engineers in the southern Ontario manufacturing sector. It was very successful from 2000 until about 2008, when the global recession hit, and many companies that had previously paid or subsidized employees' tuition were no longer willing to do so. At the same time, Ontario universities, including the University of Toronto, enhanced the content of their "regular" Master of Engineering degree programs, making them more attractive to working engineers. As a result of these factors, enrolment in the degree program has declined and the program has closed at the University of Toronto. The diplomas were developed to meet an anticipated gap in service in anaesthesia care, palliative care and pain teams, however, the anticipated gap did not materialize and enrolment in the diplomas has been very low as there is no demand for the diploma training.
